

**Mount Pleasant Model Aircraft Club**  
October 21, 2014 Monthly Meeting

Meeting was called to order at 6:10 p.m. by Vice President Rick Harless in absence of President.

- The minutes of the last meeting were distributed. Motion to approve by John Harper, seconded by Monte Stratton. Motion carried.
- Thirteen new club hats were purchased by members at \$10.00 each. They are sharp! Eleven additional hats are available at this time. They will be at the November club meeting.
- Treasurer's report showed a balance of \$310.13. Motion to approve by Norm Eifler, seconded by John Harper. Motion carried.
- Susie had pictures of the new picnic tables and revamped bleachers recently completed by Monte Stratton. He was given a round of applause and thank you for a job well done!
- Susie presented a report on club t-shirts with club logo screen print. It was decided to limit shirt colors to blue and white. A tentative order form was sent around and will be at the next meeting. Screen print set up charge has been paid, and we need orders for at least 24 shirts in order to make this happen. Prices are between \$8.00 and \$11.00 depending on what size you choose. Final size selections and money will be due at the November meeting so we can place the shirt order.
- Discussion took place on the possibility of securing the Baptist church gym for our own indoor flying activities in addition to the dates at Finch Field House that Randy Gibson has arranged. The charge for the year's sanction which provides liability insurance for the church is \$60.00 for the year. Barry Kissoondial made a motion that we pay this fee for 2015 with a schedule of one date in each of the first three months of 2015; we could then schedule some dates in the fall of 2015 if we wished. Seconded by Susie Harper; motion carried. President Brian will proceed on securing the sanction. Milo Frisbie will check on possible dates.
- There was further talk about future field improvements, i.e., charging station, small paved area for smaller aircraft. Lots of discussion but it was agreed that further study is needed.
- Field winterization was discussed. Toilet has two gallons of RV antifreeze and we need to put as many tables inside the shed as we can and stack up the rest under the shelter.

- Limited discussion on both New Year's Day Fly and a potential electric fly fund-raiser event next summer. We will fly New Year's Day, weather permitting. Doug Jennings is looking into the AMA requirements for setting up a sanctioned event.
- Election of officers for next year took place. Last month's nominations were: Brian Krulicki for President, Rick Harless and George Jennings for Vice President, and Susie Harper for Secretary/Treasurer. Paper ballots were issued and after the count the following officers were elected: Brian Krulicki, President; George Jennings, Vice President; Susie Harper, Secretary/Treasurer. New officers will assume responsibility as of November 1, 2014.

Motion to adjourn was made by Susie Harper, seconded by Norm Eifler. Motion carried and meeting adjourned.
